



# PUBLIC NOTICE

This notice is to inform the public that the South Carolina Department of Health and Environmental Control (DHEC) is taking public comments on a Corrective Action Plan (CAP). This CAP addresses the cleanup of soil and groundwater contamination at the facility listed below. The contamination was caused by petroleum products released from the Underground Storage Tank system at this facility.

**FACILITY:** Circle K #2720886, 4315 Savannah Hwy., Ravenel, SC 29470

**APPLICANT:** Circle K Stores, Inc., 1100 Situs Ct. STE 100, Raleigh, NC 27606

**SUMMARY OF CAP:** Petroleum and petroleum byproducts naturally break down over time through chemical, physical, and biological processes. These processes are called natural attenuation. ATC-An Atlas Company has submitted a CAP proposing the use of the following technologies in addition to natural attenuation to clean up the contamination.

Trap & Treat® in-situ chemical/biological application of BOS 200®: The product BOS 200® is mixed with water and a facultative blend of microbes to form a slurry. The slurry is then injected into the subsurface creating an enhanced or ideal environment for the chemical, physical, and biological processes, where contaminants are adsorbed or 'Trapped' to the BOS 200® and broken down 'Treated'.

**DHEC is accepting comments on the CAP through October 6, 2020.** Interested persons are encouraged to visit our webpage at [www.scdhec.gov/CircleKRavenel](http://www.scdhec.gov/CircleKRavenel) to view the CAP and additional information about the ongoing cleanup of petroleum products at this site. The webpage is updated with new information as it becomes available.

**DHEC will hold a virtual community meeting to discuss the CAP on September 22, 2020, at 6:30 pm.** The community meeting will be an informal conversation with an opportunity to ask questions and receive answers from DHEC staff and the onsite contractor performing the cleanup. This event is being held virtually using an online platform in a live-event setting. This platform will allow continued community engagement in DHEC's process while following local, state and federal guidelines for social distancing and avoiding large group gatherings. Comments and questions made during the meeting will be heard by DHEC staff and others who are participating remotely. Interested persons can join the meeting remotely using a phone, computer, or other mobile device.

Anyone who plans to participate in the meeting should complete the registration form on DHEC's webpage prior to the event. Access to the meeting will be open at 5:30 pm on the date of the event. [An access link and instructions on how to join by phone or computer will be available on the webpage at that time.](#) We encourage log-in at least 15 minutes prior to the start of the meeting at 6:30.
