

Summary: Suja Properties LLC (Individual/Entity), located in Belton, South Carolina, owns and operates underground storage tanks located in Greenville, South Carolina. On August 4, 2016, the Department issued a Notice of Alleged Violation because the annual tank registration fees for fiscal year 2018 had not been paid and on August 25, 2016, the Department issued a Notice of Alleged Violation/Notice of Enforcement Conference because the USTs had been temporarily out of service for more than twelve (12) months, did not meet corrosion protection standards, and there was no current financial responsibility documentation on file. The Individual/Entity has violated the SUPERB Act and the South Carolina Underground Storage Tank Control Regulations, as follows: failed to pay annual underground storage tank registration fees; failed to permanently close USTs that have been temporarily out of service for greater than twelve (12) months and do not meet current corrosion protection standards; failed to demonstrate financial responsibility for an UST system; and failed to submit evidence of financial assurance to the Department upon request.

Action: The Individual/Entity is required to: submit a completed Tank/Sludge Disposal form; permanently close the USTs and submit an UST Closure and Assessment Report; submit a completed Certificate of Financial Responsibility form and provide evidence of financial assurance if contamination is found; pay annual underground storage tank registration fees in the amount of three thousand, twenty-five dollars (\$3,025.00); and pay a civil penalty in the amount of thirty-three thousand, three hundred fifty dollars (**\$33,350.00**).

On November 1, 2016, the Department conducted an inspection and issued a Notice of Alleged Violation because there was no A/B Operator log and no release detection records available at the time of the inspection and on February 1, 2017, the Department issued a Notice of Alleged Violation because there was no current financial responsibility documentation on file. On August 4, 2017, the Department issued a Notice of Alleged Violation because the annual tank registration fees for fiscal year 2018 had not been paid. The Individual/Entity has violated the SUPERB Act and the South Carolina Underground Storage Tank Control Regulations, as follows: failed to pay annual underground storage tank registration fees, failed to provide adequate release detection methods for an UST system, failed to validate monthly requirements have been performed at the facility, failed to physically visit each assigned facility once a quarter, failed to demonstrate financial responsibility for an UST system, and failed to provide evidence of financial assurance to the Department upon request.

Action: The Individual/Entity is required to: submit an A/B Operator log; tank tightness test results for all USTs; submit a completed Certificate of Financial Responsibility form and provide evidence of financial assurance; pay annual underground storage tank registration fees in the amount of six hundred five dollars (\$605.00), and pay a civil penalty in the amount of nine thousand, four hundred seventy-five dollars (**\$9,475.00**).

On May 9, 2017, the Department noted unresolved open violations for failure to pay annual underground storage tank registration fees for fiscal years 2008 through 2017, and there was no financial responsibility on file with the Department. On August 3, 2017, the Department issued a Notice of Alleged Violation because the annual tank registration fees for fiscal year 2018 had not been paid. The Individual/Entity has violated the SUPERB Act and the South Carolina Underground Storage Tank Regulations, as follows: failed to pay annual underground storage tank registration fees; failed to provide records to the Department upon request; failed to maintain corrosion protection and release detection on a temporarily closed UST; failed to demonstrate financial responsibility for an UST system; and failed to submit evidence of financial assurance to the Department upon request.

Action: The Individual/Entity is required to: submit proof that the regular unleaded UST has been emptied to less than one inch of residue; submit proof that the metal piping components in the regular unleaded and premium STPs are protected from corrosion; submit a completed Certificate of Financial Responsibility form and provide evidence of financial assurance; pay annual underground storage tank registration fees in the amount of three thousand, five hundred nine dollars (\$3,509.00); and pay a civil penalty in the amount of nine thousand, five hundred dollars (**\$9,500.00**).

On October 5, 2017, the Department issued a Notice of Alleged Violation/Notice of Enforcement Conference because the USTs did not meet corrosion protection standards, there was no current financial responsibility documentation on file, and annual underground storage tank registration fees for fiscal years 2015-2018 had not been paid. The Individual/Entity has violated the SUPERB Act and the South Carolina Underground Storage Tank Control Regulations, as follows: failed to pay annual underground storage tank registration fees; failed to have the corrosion protection system inspected by a

qualified tester every three (3) years; failed to provide records to the Department upon request; failed to permanently close USTs that have been temporarily out of service for greater than twelve (12) months and do not meet current corrosion protection standards; failed to demonstrate financial responsibility for an UST system; and failed to submit evidence of financial assurance to the Department upon request.
