## Subject: Request to Modify Groundwater Monitoring and Reporting Schedule in 2023

Products (SE) Pipe Line Corporation Lewis Drive Remediation Site Belton, South Carolina Site ID #18693, "Kinder Morgan Belton Pipeline Release"

Dear Mr. Mendenhall,

On behalf of Products (SE) Pipe Line Corporation (PPL), Jacobs is submitting this letter to maintain the current number of groundwater monitoring and reporting events and the current number of groundwater monitoring locations at PPL's Lewis Drive Remediation Site (Site ID #18693), located in Belton, South Carolina (site).

As you are aware, PPL has worked diligently with the South Carolina Department of Health and Environmental Control (DHEC) over the last eight years to assess, remediate, and monitor conditions at the site. PPL has compiled a significant body of data that indicates overall decreasing trends in hydrocarbon concentrations and frequency of occurrence as shown in the First 2022 Semiannual Monitoring Report submitted to DHEC on August 26, 2022.

As presented in the Corrective Action Plan Addendum #2 submitted to DHEC on May 24, 2021, and accepted by DHEC on June 29, 2021, PPL installed three new horizontal air sparge (HAS) wells (HAS-4, HAS-5, and HAS-6) to treat areas in the Browns Creek Protection Zone (BCPZ) and Cupboard Creek Protection Zone (CCPZ). HAS-4 and HAS-5 in the BCPZ began operation on June 20, 2022. Startup of HAS-6 in the CCPZ is scheduled to occur in December 2022.

The proposed 2023 annual, semiannual, quarterly, and monthly sampling events; semiannual product recovery; and semiannual reporting schedule are based on the current Table 1 – Groundwater and Surface Water Monitoring and Reporting Plan (January 1, 2022 to December 31, 2022) accepted by DHEC on May 27, 2022.

The proposed 2023 monitoring plan is presented in the attached Table 1 and displayed on Figure 1. Ideally, PPL would like to receive a response to this request prior to December 16, 2022.
